Is it easy to leave a gift in your Will?

Wills are generally easy and inexpensive to prepare.

Unfortunately, many people put off making a Will until it's too late. When you make your Will, you decide on how the assets you've acquired in your life are distributed.

You get to choose what you care about and what values you wish to express.

Your Will allows you to provide security for family members and loved ones. You can choose to leave your valued possessions to someone special. Your Will also provides a way to identify and support the causes and organizations that reflect your values.

What types of gifts can you leave in your Will?

You may be considering leaving a gift in your Will to the Children's Hospital of Manitoba. If so, thank you. Children in our community benefit from the generous bequest of friends like you.

There are three types of gifts you can make in your Will.

1. A **specific bequest** leaves the Children's Hospital a specific amount of money. Or property such as a coin collection or a piece of land.
2. A **residuary bequest** disposes of all or a portion of assets remaining after everything designated in your estate has been distributed to loved ones. This essentially means that you give to your loved ones whatever you wish them to have, and any leftover money goes to the charitable organization.
3. A **contingent bequest** indicates that a beneficiary receives all or some of your estate depending on specific conditions.

Is my decision confidential?

All information that you share with us is confidential.

Can I make a minor change to my Will with a codicil?

Yes. A codicil is a simple change or amendment to your otherwise satisfactory last Will and testament. For example, you could add:

“I give, devise and bequeath to The Children's Hospital Foundation of Manitoba the sum of \$_____ to be used for any purpose(s) approved by the Board of Directors of The Children's Hospital Foundation of Manitoba.”

A codicil is not intended to make major changes to your Will. We recommend for any major changes, that you seek legal or financial advice from your advisors. Even for a simple codicil, professional help will make your wishes clear.

Best of all, she has no health problems and has caught up on


the growth charts with other kids her age.
